

# MINUTES OF THE MEDFORD RETIREMENT BOARD MEETING HELD on 9-29-2020 at 9:30am VIA CONFERENCE CALL AS A RESULT OF COVID-19 AND IN ACCORDANCE WITH PERAC MEMO #15/2020

Patrick Ripley motion to suspend the normal order of business for NEPC and Rhumbline to present. Motion second by Aleesha Nunley Benjamin. Motion passed by all voting in favor. Denise D'Entremont from Rhumbline discussed the following funds: S&P 500, S&P 400 and the TIPS fund referencing the Rhumbline handout dated September 29, 2020. Denise notified the Board that she is in the office in Boston just about everyday. Denise began reviewing the S&P400 returns as of August 31 and indicated that the Board has an annualized return of 9.44% since inception compared to the S&P 400 index 9.39% and a market value of \$7.598M through August. The Board is one of 37 investors and the fund size \$864M indicating that the fund holds a small amount in an ETF for liquidity - cash needs. Denise reviewed the S&P500 returns as of August 31 indicating a YTD return of 9.75% and an annualized return of 8.94% since inception compared to the S&P 500 index 8.91% and a market value of \$43.137M through August. The Board is one of 15 investors and the market value of total fund size \$872M. Denise reviewed the TIPS fund returns as of August 31 indicating a YTD return of 9.62% and an annualized return of 10.78% since inception compared to the Barclay TIPS index 10.89% and a market value of \$10.672M through August. The Board is one of 6 investors and the total market value fund size is \$243.1M. No major changes with the company with some employees working remotely. \$68B in assets under management. No questions for Denise and she left the meeting at 10:00am.

Scott Driscoll referenced NEPC's handout dated September 29, 2020. Scott reviewed the market indicating the MCSI ACWI has a YTD 4.7% as of August 31, and is in the negative as of today. Scott discussed the top 5 technology stocks that have been driving the S&P index, the election in November and a rebound in the global pandemic can negatively impact small business. There's a lot of uncertainty. Patrick Ripley asked what are next plan is, stay the course? Scott Driscoll said we structured the plan to take advantage of the downside and NEPC recommends staying the course. The plan is very liquid and structured to protect assets in a down market. Patrick Ripley answered ok, thank you. Scott continued referencing page 17 in his handout indicating that Amazon, Alphabet, Apple, Microsoft and Facebook ytd returns up 59.2% combined and the remaining 495 companies combined were -5.9% ytd. Scott reviewed plan performance indicating the plan's market value was \$210,612,542 at the end of August. During Q1 most plans were down 15% - 18%depending on equity exposure and the plan now is in positive territory +1.6%. Domestic equity is up 4.2%, fixed income is up 8.7%. Loomis multi sector is up 10.2%. Scott indicated that fixed income increases are outliers and not NEPC is not expecting the bond markets to continue with these results. Ashmore recovered a lot of the performance lost in Q1. Private equity is down 3% YTD and still outperformed the index. Rick Jordan asked if anyone has any questions? Robert Maiocco asked how long did has Medford had a position in the hedge funds? Scott answered approximately 7 years. Scott said we have 4 managers left to review this year and will reach out to William Blair and City of London for next month.
