Scott Driscoll from NEPC began his presentation referencing NEPC's handout dated March 31, 2021. Scott Driscoll provided a market update referencing page 4 of NRPC's handout. Mr. Driscoll reviewed month to date as of February 2021 indicating that the S&P500 was up 2.8% for the month and 31.3% for the one-year trailing. Mr. Driscoll indicated that the one-month trailing will change next month when March 2020 drops off. The Russell 2000 is up 11.6% YTD. Mr. Driscoll indicated that value stocks are turning around and starting to outperform growth, referencing page 13 of the handout. Rick Jordan asked Scott Driscoll how do you think the infrastructure package will affect the economy? Scott Driscoll answered that he hopes the infrastructure package will help sectors that have been left behind such as the labor and service sectors. Robert Maiocco asked Scott Driscoll what's his perspective if the fixed income continues to underperform, regarding the fixed income portion of the fund which represents 23.8%, what's your projection? Scott Driscoll answered that income core bonds, NEPC is projecting over 10 years 1.7% and over 30 years 2.7%. So we don't want to be over allocated. The fixed income portion of the fund added value during the sell off in 2020. Some of the risks are in credit and interest rate sensitivity. The TIPS portfolio will protect in an inflationary period but also provides protection by offsetting equity risk. Mr. Driscoll reviewed the net performance of the plan indicating the fund balance as of February 2021 is \$224.4M and was up 1.5% in February and 1.2% YTD. Mr. Driscoll indicated that total equity was up 3.4% in February and 2.9% YTD. Mr. Driscoll continued and reviewed prior month, YTD, 1,3 5 7 and 10 years return for international equity, fixed income, private equity, real estate and hedge funds. Robert Maiocco asked if we

discussed asset allocation last meeting? Scott Driscoll answered that last December the Board made a change to asset allocation terminating global asset manager William Blair and redistributed into equity markets and fixed income, this redistribution is in line with NEPS's current themes going into 2021. Dr. Driscoll added that NEC's assumptions have been pulled back and forecasting US large cap equities over a 30-year period to return 6.3% and a year ago we were forecasting 7% over 30 years, so our assumptions have definitely pulled back. We are striking an appropriate risk balance where we can move towards the actuarial rate of return. Scott Driscoll informed the Board that we should begin manager reviews next month and suggested we invite Loomis to the next Board meeting. Rick Jordan said ok and to coordinate with Mark Minervini.

Discussion about meeting in person next month and it was decided to continue meeting using gotomeeting.

# 7. Unfinished Business:

#### **Personnel Recommendations**

Follow-up to last month's recommendations on performance appraisal and salary. Rick Jordan asked if we need to review anything from last month? James Vieira answered yes. James Vieira said last month we classified two positions, for Carol Powers we classified her position as CAF 7, Step 5 and for Michelle LaJoie's position CAF 12- Step 5 and there is a 22% difference in salary to avoid a salary collision. During last month's meeting we voted to change the functional title of Mark Minervini's position to Executive Director and we agreed that I (James Vieira) would do a survey and have a recommendation for the Board on the salary, using the money that was funding the 4th position and the recommendation being made will stay within budget. In the survey, there is a salary comparison of 10 Boards with a membership size comparable to ours and looked at the average salary for the Executive Director, which was \$110k and looked at the experience and compared them to our Executive Director and what he brings to the table, which is an average of 28 years. So, I'm (James Vieira) making a recommendation that we upgrade Mark Minervini title to Executive Director and fit it into the salary scale at a CAF 19 Step 3. This is going from a CAF 17 to CAF 19 and will elevate his salary to \$109,317 and allows 2 more years growth to step 5. This is an increase of \$450/month and including the other two upgrades, stays within the salary we budgeted for the 4th position that we agreed, due to our advancement in technology, we do not need in the future.

James Vieira motions to upgrade the Executive Director's salary to CAF 19 Step 3 at \$109,317. Motion second by Robert Maiocco. Roll Call Vote: Patrick Ripley: "YES", Robert Maiocco: "YES", James Vieira: "YES", Rick Jordan: "YES"

Rick Jordan said vote is unanimous and agrees with what James Vieira spoke about and it's appropriate that we get Mark in line with the people who are in our universe.

James Vieira said there's one more piece we need to discuss to wrap this up, that we discussed lightly at the last meeting, and it addresses our fiduciary responsibility and I'm recommending that we put in place a performance appraisal review for Mark Minervini. There are three ways we can do this; Mark Minervini sent a copy of an appraisal form and we can use this form together at a meeting and do an evaluation as a discussion, or we can use that form to evaluate him individually and compress the results into one form or we can sit at the table and come up with a form, but there should be something in our files that shows we evaluated our Executive Director and



that we are satisfied with his performance and we all sign to it. The banking commission does it for banks and the national credit union league does it for credit unions and I feel we should have something on file just in case PERAC auditors ask for it. Rick Jordan said very good Jim and asked if someone will put that in the form of a motion

Patrick Ripley motions to setup a performance appraisal review form to evaluate the Executive Director. Motion second by Robert Maiocco. Robert Maiocco commends Jim on his work and said Mark you deserve it. Patrick Ripley on the motion, said that he is totally happy with the Administrator and thanked James Vieira for his professionalism in handling this and presenting it in a way easy to understand.
